Red Rock Ranch was chosen as One of Seven neighborhoods in the Nation!

Sites of Excellence 2 year pilot project (National Fire Protection Association/NFPA): targeted homes in high wildfire threat/risk area bordering national forest; conducted education visits, scheduled assessments, encouraged mitigation Neighbor Helping Neighbor initiative: dozen plus volunteers conducted mitigation for deserving neighbors

2020 Firewise Plans: continue home assessments, resident mitigation, selective road/right-of-way clearing, homeowner education, and neighbor-to-neighbor assistance.



HOME ASSESSMENTS

We are hoping to have more homes in the area get Firewise assessments for their homes. There are a few steps one can take to harden their home and protect it from an ember fire. A majority of homes that burn in a fire burn before the fire get to the home... in an ember fire. One of our neighbors has invested his time to be nationally certified to do assessments FOR US! This is information for you, only. Take stock and do what you can to protect your home.

FIREWISE 2019 ACTIVITIES

Wildfire education and awareness for residents: distributed wildfire information packets to all residents as part of National Wildfire Community Preparedness Day

- -Home/safety assessments: 19 completed (1.5 hrs each) with recommendations for homeowners (Zone 1, 0-5 ft; and Zone 2, 5-30 ft)
- -Homeowner mitigation and chipping: conducted four (4) chipping days in 2019 averaging 72 volunteer hours per day (12 volunteers).
- -Mitigated Properties two year total (2018-19): approximately 50% of HOA homes (90+) have conducted some mitigation
- -Road/Right of Way (ROW) clearance: improved safety at two intersections (Sandstone Rd/Red Rocks Dr) and Forest View Rd/Aspen Way)

DO YOU OWN A VACANT LOT?

Your neighbors need you to participate in the FIREWISE program. You own the lot, you own the fuels, you own the fire, and the consequences. There is a significant amount of over growth in the vacant lots with an abundance of dry fuels just waiting to burn on one of our red flag days. This fuel will escalate the spread of any fire and increase the risk to all residents as they try to exit the neighborhood during a wildfire incident. Firewise committee is asking all lot owners to reduce fuel levels on their lots, clear back and thin scrub oak and trees at least 5 feet from the road, and become aware of the very real fire danger we live in. TALK ABOUT COVENANTS

Our covenants have had minimal changes in the past few years and are in great need of updating to keep current with recent laws and other contemporary covenants. The idea is to update and not change most of the covenants. Come to the annual meeting and give us your input. This will be a lengthy process and may take a while before we put the changes to a vote. 51% of the homeowners approval is required to pass any changes.

TRASH CANS

Please secure trash cans and put them away after your trash day. This will eliminate one source of food and smells for wildlife, keeps our neighborhood looking great and is in the current covenants.

PARK UPDATE!

We have had received a few estimates on the revitalization of our park. The estimates have been substantially out of our budget. In efforts to try to make our park a destination for our children we will be working this summer with some more affordable updates.

With this being said we will be planning a park clean up around our trash amnesty days. Our ultimate goal for the park cleanup is to clean and paint the shelter, as well as start cleaning the garden area out behind the tennis court.

In the summer months to come we will be repairing the tennis court, repainting, and are discussing the possibility of putting up basketball hoops as well as new netting for the court.

WE LOVE DOGS!

There are a few things to consider with dogs. Please make sure you have a happy, quiet dog. Barking will occasionally not be avoidable, but do not leave your dog outside all day and night if it is going to bark constantly. This doesn't make for a happy puppy.

There have been a few reports of aggressive dogs in our area. This is not safe for kids on bikes and neighbors walking past. No one really wants to report these animals, but no one wants to get bitten, either. That would be harmful to both dog and neighbor. Please don't allow your dog to be "that dog!"

Dogs like to go after wildlife, this can be bad for the dogs and the animals...the dog may not come out ok.... Keep your dog under control and safe. This may be a rural area, but you still need to pick up the "presents" your dog leaves behind.
